








Julio Builds Resilience and Self-Esteem

Our School-Based Counselors work closely with staff at over 35 school campuses throughout the county. So, when second-grade student, Julio, exhibited peer relationship problems and lack of focus in the classroom, he was referred to the school counseling by his teacher.

His counselor discovered that Julio's parents had recently divorced, and he was experiencing intense nightmares that were disrupting his sleep and affecting his mood. Julio was having difficulty making friends because of inappropriate pushing and name-calling.

Through weekly therapy sessions that incorporated art, role-play, and play therapy, Julio opened up about his fears. Julio and his counselor practiced assertive communication skills—ways for Julio to express his feelings in a calm, yet confident way. Soon, Julio began using these skills with his family and friends.

After four months of therapy, Julio's nightmares stopped, and his self-esteem improved. He is more resilient and capable of handling life's challenges. He has built healthy friendships and participates more confidently in the classroom.

Being The Difference for Our Youth







Family Service Agency partners with Mental Wellness Center and Youthwell to provide Youth Mental Health First Aid classes.

Close to 700 parents, educators, health professionals, and community members have joined the movement to "Be The Difference" for youth in Santa Barbara County. By completing an eight-hour class in Youth Mental Health First Aid, they learned to recognize signs of mental distress, gained strategies for listening and communicating, and identified ways to provide help to struggling youth.

Here are some comments from the participants:

- A parent who took the class in February shared her appreciation for the new positive relationship she has with her kids.

 "I no longer barge into their rooms, take away their phones, or try to fix everything."
- A school principal commented that what he had learned in class that morning helped with a student in crisis that same afternoon.
- A weary mother and father left the class early to take the information home and immediately get help for their child.
 They later contacted the instructor to share that the class made all the difference for them.

Mother and Son Reconnect



To avoid the violent fights between his parents, Alberto spent most of his time out of the house. He visited friends, often staying on the streets until late at night. Alberto had his first encounter with the police at age 14. By the time he was 15, he was placed on probation for stealing. Thinking that Alberto would benefit from improved relationships at home, his probation officer referred him and his family to FSA's Strengthening Family Program.

On the first day of class, Alberto was quiet and sat as far as possible from his mother, Rosa. He was angry with her. He blamed her for his parent's separation.

As the weeks passed, Alberto opened up more and sat closer to her. On week eight, Alberto won a Starbucks gift card raffled during class. He invited his mother to go to Starbucks, where they talked for more than two hours.

The class gave Rosa and Alberto the opportunity to spend time together without screaming or blaming. Now, they have dinner together as a family at least twice a week. Rosa offers more praise, and Alberto has stayed out of trouble.

Helping Families Develop Positive Relationships

Ten-year-old Leticia's frequent tantrums often lasted for an hour and occurred multiple times a week. Concerned about her disrespectful and verbally aggressive behavior, her parents contacted the Outreach Mentor at their school, who referred them to FSA's in-home parent education program in Santa Maria.

Our parent educators met with Leticia's parents for several weeks, presenting pro-social skills. The parents learned ageappropriate behaviors for their daughter, the importance of praise and celebrations, the benefits of setting household rules and routines, and the importance of being consistent with rules and consequences.

A breakthrough occurred when the parents realized they were yelling a lot and saying things they did not mean out of anger. Leticia's parents learned the importance of family play and began implementing it daily. As a result, Leticia learned to express her needs in a positive way, and her tantrums stopped.

Leticia has learned to respect the household rules, and the family is enjoying a more peaceful home environment.

Leticia's parents are grateful for FSA's assistance in helping them develop more positive interactions with their daughter.



Working Through the Stress of Caregiving

When her father, Lewis, was diagnosed with Lewy body disease, Shirley felt overwhelmed. Lewis had recently moved in with Shirley and her husband, and the couple realized they were facing new challenges on how to deal with Lewis and his symptoms.

Shirley was sad, frustrated, and at times, angry and scared. She loved her father vet felt illequipped to care for him. Believing it was her duty to care for her father, she felt guilty for having any negative thoughts.

Shirley began participating in our Caregiver Support Group and found comfort from the other members as well as a place to share her fears and concerns.

She also worked through her feelings of guilt and frustration through individual counseling. Shirley was able to recognize and discuss how her father's presence put additional strain on her marriage.

Because of the support she found in the group and individual counseling, Shirley says she feels better equipped to manage her father's care. She learned to care for herself, too.

A Family Comes Together For Their Mother's Care

Iris was living in a long-term care facility when the symptoms of her dementia progressed. Her family members disagreed about the level of care she required, and a feud erupted about what to do next.

The family contacted FSA's Long-Term Care Ombudsman program for help. Our Ombudsman collaborated with the staff at the facility to discuss Iris' changing condition. Together, we met with the family members to hear their concerns and explore the safest alternatives for Iris.

Eventually, the entire family began to accept the changing progression of Iris' condition. By guiding the family in its decision to move Iris from assisted living to skilled nursing within the same facility, Iris is now receiving the care she needs, and the family members are once again at peace with one another.






